THE PORTFOLIO

QuadReal offers breadth and depth of management experience and engagement to tenants, residents and their visitors. We manage the real estate and real estate debt programs of BCI, in addition to real estate on behalf of RBC GAM. Globally, the portfolio includes 133 million square feet of commercial real estate and over 53,000 residential rental suites and student housing for 20,000 occupants. The diversity of the portfolio is represented by Bayview Village and Commerce Court in Toronto, World Exchange Plaza in Ottawa, SODO in Calgary, and Park Place and NorthWoods Village in Vancouver.

While we continue to expand strategically in Canada, we have also identified select global markets where we invest in and develop commercial real estate. QuadReal oversees a growing portfolio of over \$18 billion in real estate assets internationally, including the U.S., Asia-Pacific and Europe. These markets provide significant opportunity to acquire and develop assets that meet the need for steady, reliable long-term yields.

Building geographic expertise in global cities such as New York, London, Hong Kong and Toronto is fundamental to QuadReal's active international acquisition and development strategy. While these core markets are all unique, they share an important trait: they are the world's collective heartbeat, driving economic, cultural, social and technological innovation.
